Asbestos Removal at Osborn Hill Elementary School  
Fairfield, Connecticut

Dear Concerned Parties:

Osborn Hill Elementary School, located at 760 Stillson Road in the Town of Fairfield is undergoing a gymnasium clean-up and renovation. This project is underway and abatement is required. There are asbestos-containing materials that have been identified within the gym. These materials will be removed, and all areas in the gymnasium thoroughly cleaned.

The intent of this letter is to inform you of the project to remove the asbestos. This abatement project is expected to start on Friday, December 5, 2014 and is expected to be completed Tuesday, February 3, 2014 (+/-).

The school will be occupied during the asbestos removal/clean-up in the gymnasium. The portions of the school that are occupied will be separated from the asbestos removal project by sealed hard barriers to isolate the school from the work areas. The abatement work will take place during and after the school day, 6:30 a.m. to 3:30 p.m. The on-site project monitor will take air samples to verify that no fiber/dust particulate migrate to the occupied portion of the school.

The abatement will be performed by a state-licensed asbestos abatement contractor, Environmental Consulting & Contracting, LLC, Connecticut Asbestos Contractor License # 000388, under contract to Fairfield Public Schools. The project will be monitored continuously by AMC Environmental, LLC, an independent environmental consultant. The monitoring includes, but is not limited to, pre-work inspection, inspection and air sampling during the abatement process, final visual inspection, and final air clearance testing.

As required by the State of Connecticut Department of Public Health, this notification is being sent to all parents and guardians of the children/students, faculty, and staff of Osborn Hill Elementary School.
