**PROMOTION PERIOD**: The Skyhour "Iceland Giveaway" ("the Promotion") begins at 12:00:01 p.m. Eastern Standard Time ("EST") on April 17, 2018 and ends at 11:59:59 p.m. EST on April 22, 2018 (the "Promotion Period.")

ELIGIBILITY: The Promotion is open to legal residents 18+ years and older that reside in one of the fifty (50) United States and the District of Columbia and excludes residents of Puerto Rico and other U.S. territories and possessions. Following the accounts, creating a Skyhour account and submitting a comment requires a mobile device and therefore message and data rates may apply. Entries posted by a private Instagram account will not be recognized; Message and data rates may apply. Text messaging and wireless services are not available in all areas. Limited to one entry per Skyhour account and Instagram. All entries must be received by 11:59:59 PM EST on April 22, 2018 to be eligible.
