

There are nine required documents in the Advanced Placement US Government and Politics course. These nine documents represent seven different concepts in the study of American government.

This summer you are required to examine two of these seven concepts in more depth. You must explore the first concept and then you may pick any other concept of your choice. You will need to read and analyze the documents associated with the concept. Additionally, you will identify four current event articles (from the past year) that relate to the concept. Using your analysis of the concept's documents and the current event articles you identified, you will write a one page response explaining your understanding of the concept in the current political atmosphere.
